- HHS Office of Grants Policy and Closeouts, followed by the COGR F&A Survey. Jeffrey Johnson, Associate Deputy Assistant Secretary for Grants, Department of Health and Human Services (HHS), will provide an introduction on the roles and responsibilities of the HHS Office of Grants Policy and how his office works with all of the HHS Operating Divisions. • Human Research Regulations and Institutional Effective Management Practices

The Research and Regulatory Reform Committee will discuss findings from the COGR/APLU and HHS Office for Human Research Protections analyses of public comments on the Common Rule Notice of Proposed Rulemaking as well as related meetings, outreach and next

steps. The NIH Single IRB Policy, which we anticipate will be published prior to Memorial Day, will also be discussed. The committee will provide an update on a checklist under development for reducing administrative burden at the institutional-level for investigators and administrative staff in areas such as human and animal research, financial management, subcontracts, training and proposal preparation. The Research Compliance and Administration Committee Director will present an overview of the revised March 2016 edition of the COGR Guide "Managing Externally Funded Sponsored Programs: A Guide to Effective Management Practices."
