- 10: 00 a.m. 12:00 p.m. <u>Working Through Frenzy in Washington.</u> The session will cover a host of issues including the status of the federal and research budget, immigration reform, free speech on campus, implications of tax reform, and other topics that are drawing significant attention in the Nation's Capital. Some of the discussion will be prospective, some retrospective, and all discussion will be around the common theme of how Washington currently is functioning and what to expect for the rest of 2018.

The discussion will begin with the current climate, recently introduced legislation, issues at the federal level pursuant to differences under the Farm Bill and the Controlled Substances Act. We'll hear from our panel experts on state specific issues (e.g., California, Colorado, and Washington State) and close with next steps for COGR advocacy and taking questions from the audience.

Recent reports, including the OIG's report on responsible conduct of research, ongoing or recently completed audits, including reviews of single audit and subrecipient monitoring, and planned audits that impact grantees will be discussed.
