Dear Mr. Dong and Ms. Murray:

We appreciate the time you have taken to engage with a diverse range of grantees and recipients of Federal awards. As you work towards a final version of OMB guidance, we recognize the challenges you face to meet the needs of all stakeholders. However, we believe some of that challenge can be minimized by assuring you that the broad community of grant recipients – State, Local, and Tribal Governments, Nonprofits, Nonprofit Research Organizations, Commercial Organizations, and Institutions of Higher Education – are united in support for meaningful and substantive grants reform.

As a follow up to a July 31<sup>st</sup> letter from COGR, the Coalition in Support of Innovative (CSI) Grants Reform is poised to support OMB and the COFAR in a final version of OMB guidance that provides our community with a reduction in administrative and regulatory burden. However, as the COGR letter highlights, we are concerned that an outlying perspective could jeopardize those reform opportunities that could provide regulatory relief. We have a number of ideas for genuine grants reform and would like the opportunity to provide our perspective of the systemic issues associated with federal grants management and the true reforms we seek.

Consequently, we request a meeting with OMB and the COFAR to review our issues and concerns. While we remain cautiously optimistic that the President's mandate will prevail, a meeting between CSI Grants Reform and the COFAR will help us to understand any dynamics that may detract from meaningful and substantive grants reform. We are committed to our advocacy for a final version of OMB guidance that supports increases in productivity and efficiency, and ultimately, allows our community to deliver the most effective outcomes on federal programs.
