Dear Ms. Harrison and Mr. Mackey,

The Association of American Medical Colleges (AAMC), Association of American Universities (AAU), Association of Independent Research Institutes (AIRI), Association of Public and Land-grant Universities (APLU), Association of Research Libraries (ARL), Council on Governmental Relations (COGR), and National Association of College and University Business Officers (NACUBO), collectively the "Associations," appreciate the opportunity to respond to OMB's Request for Information (RFI) regarding 2 CFR 200, chapters 1 and 2. This is an important initiative being led by OMB's Office of Federal Financial Management and has the potential to make a significant contribution to the quality and effectiveness of the research environment.

Our associations are enthusiastic about addressing issues that will result in a reduction of administrative burden. However, with the short 30-day response timeline, we are concerned this will restrict our ability to provide the most robust and potentially beneficial response. *Consequently, we are requesting a 30-day extension—from March 13 to April 12*. Our longstanding and productive partnership always has been premised on serving the grantee community first. While we understand the sense of urgency OMB has to finalize the revisions, experience, precedent tells us that a 30-day extension will allow for more thorough and thoughtful comments, will add value to the response to the RFI, and allow for more productive coordination across the higher education community (and ultimately less work for OMB as you sift through responses from a large and diverse group of stakeholders).

Thank you for your leadership in advancing these issues, which are of the highest priority for the research community. We look forward to working with OMB on this important project.
