

### **Research Ethics & Compliance – Major Issues**

- Office of Research Integrity (ORI) <u>Notice of Proposed Rulemaking on Public</u> <u>Health Service Research Misconduct Regulations</u>
  - Major changes to 2005 regulations!
  - COGR, AAU, AAMC, APLU, & ARIO <u>filed request</u> to extend comment period from Dec. 5, 2023 to Jan. 19, 2024
  - Institutions should consider sending letter of support for extension and commenting!
- Research Security
  - Awaiting final research security program standards
  - <u>Analysis of NIST Safeguarding International Science Research Security Framework</u> developed to assist institutions in implementing NSPM-33
  - REC will work with RSIP on analysis when standards are issued and with CFC on Phase II of Research Security Costs Survey
- Biosafety
  - <u>Comments</u> submitted on changes to Dual Use Research of Concern and Potential Pandemic Pathogen Care and Oversight (P3CO) Policy Framework
  - Potential governmental move from list-based to full risk-based regulation of pathogens

# Additional Items & Projects for 2024

- Update to <u>Framework for Review of Individual Global Engagements in</u> <u>Academic Research</u> in light of evolving research security environment
- Dept. of Energy (DOE) clarified that its Interim COI Policy does not require reporting of significant financial interests directly to DOE, and that it will correct this item where it appeared in certain terms and conditions.
- NASA issued its final financial COI policy which, in response to comments, is now modeled after NSF's FCOI Policy.
- Continuing response to Office of Laboratory Animal Welfare (OLAW) efforts on reducing burden in laboratory animal research.
  - COGR has responded to multiple RFIs and will revisit <u>COGR, FASEB,</u> <u>AAMC, NABR Reforming Animal Research Regulations Report</u>

  - ➢ Henry Wixon; Chief Counsel

  - Mojdeh Bahar, Associate Director for Innovation and Industry Services
- Focus on the Domestic Manufacturing Requirement in <u>EO</u> <u>14104</u>
  - New Guidance and Process forthcoming and available for comment under an RFI
  - ➢Goal is to leverage more agencies using iEdison to gain better/consistent data
- iEdison improvements continue and RSIP will be working to collect solutions/suggestions regarding the use of iEdison

## Research Security & Intellectual Property (RSIP)

- NIST committed to releasing the inter-Agency <u>March-in</u> <u>Authority report</u> for public comment but the timing of such a release is not clear.
- New Cybersecurity FAR Clauses
  - Standardizing Cybersecurity Requirements for Unclassified Federal Information Systems currently open for comment.
  - Cyber Threat and Incident Reporting and Information Sharing currently open for comment.
- Still waiting on final FAR rule on CUI! Stay tuned.
