



## Research Ethics & Compliance (REC): Updates & Emerging Issues

#### Updates:

- REC meeting with Office of Laboratory Animal Welfare (OLAW) representatives
  - Survey of institutions and researchers re. efficacy of OLAW efforts to reduce admin. burden
  - OLAW site visits
  - 3 upcoming RFIs use of existing IACUC review flexibilities, exemptions from IACUC review, & reporting of non-compliance
  - FDP standard procedure & universal protocol repository
  - NASA application of PHS Policy to certain cephalopods
- REC meeting with NIH re. role of certificates of confidentiality in protecting human subjects' reproductive health information:
  - COCs follow the research and its data
  - Cannot be used to circumvent mandatory state reporting; researchers must inform subjects of limitations

#### Additional REC Activities:

- Response to NIH RFI on hurdles in conducting cannabis research
- Institutional efforts to improve the research work environment safety by preventing and addressing harassment issues
- Implications of OSTP announcement <u>Ensuring Free, Immediate, and Equitable Access to Federally Funded</u> <u>Research</u>

## Research Ethics & Compliance (REC): Hot Topics & Priorities

- Response to <u>Office of Research Integrity's (ORI) Request for Information</u> (RFI) on Research Misconduct Regulation (42 CFR Part 93).
  - Developing a joint response with Association of Research Integrity Officers (ARIO)
  - Coordination with other associations that will be commenting
- Considerations in handling human research participants' data in developing and implementing data sharing and management plans.
  - Provision of comments to NIH in response to RFIs on this topic
    - <u>NOT-OD-22-131</u> Human Subjects Data; <u>COGR Response</u>
    - <u>NOT-OD-22-064</u> American Indian/Alaskan Native Data; <u>COGR Response</u>
  - Development of chapter in COGR's data sharing and management Readiness Guide
- Continuing focus on conflicts of interest and conflicts of commitment in the science and security space.
  - Assessing impact of CHIPS & Science Act, including impact on RCR training
  - Updating <u>COGR conflict of interest publication</u>
