Federal Demonstration Partnership

- Association of federal agencies, academic and nonprofit research institutions, and research policy organizations that work together in a collaborative initiative to streamline the administration of federally sponsored research.
- Began in 1986 as the **Florida Demonstration Project** to develop and test new grants management procedures. Founding members: DOE, NSF, NIH, ONR, USDA, the Florida State University System, and the University of Miami.
- Renamed the *Federal* Demonstration Project (phase II) in 1988; then designated the *Federal* Demonstration *Partnership* (phase III, 1996-2002). GUIRR serves as neutral convener of and secretariat for the FDP.
- TODAY: Successful organization spanning 30 years. Each phase concentrates on well defined thrusts, with a deliberate retooling of administrative structures between each phase.
- Current membership (phase VI) consists of 10 federal agencies and 154 institutions receiving federal grants (mostly universities).



The FDP's Main Goals

 Exchange thoughts, ideas, and feedback on current and proposed research administration policies and procedures

 Reduce the administrative burdens associated with federal research grants and contracts

Identify potential improvements and initiatives; demonstrate possible solutions

FDP Accomplishments

- **Expanded Authorities** Agencies confer operating authorities to the grantee for cost-related and other prior approval requirements for many activities and expenditures.
- **FDP Subaward Agreement** A model subaward agreement that may be used by any institution.
- Standard Government-Wide Terms and Conditions Legal language extended to all federally funded university research institutions nationwide under a joint OMB-OSTP initiative
- **Faculty Workload Survey** Surveys (2 completed, 1 now) of administrative responsibilities associated with managing federal research grants
- Public Health Service (PHS) Financial Conflict of Interest (FCOI) Clearinghouse Online system where any institution can easily certify its compliance with the regulations and search to confirm the compliance of other institutions.
- **Expanded Clearinghouse** Publicly available organizational profiles to facilitate subrecipient entity monitoring and subaward issuance obligations of pass-through entities



University-Industry Demonstration Partnership

- Product of over two years of discussion by a predecessor group, the University-Industry Partnership: ~35 individuals assembled by the Industrial Research Institute (IRI) and the National Council of University Research Administrators (NCURA)
- Purpose of this early U-I Partnership: to deliberate on the causes of and potential solutions to the difficulties facing universities and companies when attempting to work together.
- Four outcomes were generated during its five initial meetings:
 - A set of Guiding Principles for University-Industry Endeavors
 - A compendium of Living Studies that describe how the Guiding Principles apply to day-to-day IP negotiations
 - A National Summit held in April 2006 to share the philosophy and practices distilled from the Partnership
 - Concept and design for a new alliance, the University-Industry Demonstration Partnership
- UIDP modeled after the FDP



University-Industry Demonstration Partnership VISION

To nourish and expand collaborative partnerships and to promote discovery, innovation, and competitiveness in the U.S. economy for public benefit.



University-Industry Demonstration Partnership MISSION

The UIDP will form a coalition of willing participants to engage in a series of *collaborative experiments* on new approaches to sponsored research and the broader strategic elements of a healthy, long-term university-industry relationship based on advancing competitiveness and innovation in the U.S. economy, in maintaining research infrastructure, and in educating highly skilled scientists, engineers, teachers, and workforce.



UIDP Will Adhere to Guiding Principles

 Collaborations Consistent with the Respective Missions of Universities and Industry

The UIDP will support the mission of each partner, as it will be balanced between corporate and university membership and thus their respective interests.

Foster Long Term Relationships

Focus of the UIDP will be institutional experiments in new approaches to university-industry partnerships that can move relationships up the value chain from short-term tactical to long-term strategic.

Streamline Negotiations

The UIDP will undertake initiatives that remove barriers and catalyze U-I collaborations.

The UIDP has demonstrations at the core but encompasses a larger information-sharing forum.





University-Industry Demonstration Partnership ORGANIZATION

From 2006 to mid-2015, GUIRR served as the neutral convener and institutional home of the UIDP. UIDP functioned as an active albeit semi-autonomous project of GUIRR. GUIRR:

- Processed proposals
- Hired contractors and staff
- Handled development and maintenance of financial/budget functions
- Provided meeting space and supplies

The structure required approval from the National Academies Governing Board Executive Committee (GBEC)



UIDP Acquires Independence

In late January 2015, the UIDP became incorporated in the state of Delaware as a free-standing, independent, 501(c)(3) membership organization.
