The projected Year One cost per institution—for institutions of all sizes—is significant and concerning ...

To be Released ...

... This figure could range from over \$100,000 for small research institutions, to over \$400,000 for mid- to largevolume research institutions. While some of these Year One expenses will be one-time costs, a sizable portion are recurring annual research compliance costs. In total, the cost impact to the entire research community for compliance with the **Disclosure Requirements in Year One could well exceed \$50** million. All institutions will experience significant cost and administrative stress, and the smaller research institutions may face a disproportionate impact.
